9 – 10 am	Insights from the Crowd: Using the Power of UGC to Enhance Authoritative Information in a	Mid Deck Disaster

Virtually every large-scale disaster presents the same signal-to-noise conundrum: in the absence of authoritative, real-time information, people scour the web and leverage "the crowd" to fill in gaps of knowledge. While it remains a challenge to identify the signal in this noise, there is tremendous potential to leverage this crowd to improve overall situational awareness, aid relief operations and enhance public communications. This "virtuous cycle" of feedback and information flow, channeled from the crowd into official sources and back to the public, is an increasingly robust and important phenomenon. We will explore cases where crowdsourced information has been used effectively to complement authoritative information sources as well as address key concerns like the trustworthiness, accuracy, and timeliness of information from social media and other crowdsourced channels to brainstorm how best to overcome these issues moving forward.
