This panel will examine the homeland security and emergency management implications of foreign governments acquiring large parcels of land across the United States. Panelists will explore potential risks to national security, critical infrastructure protection, supply chain resilience, and impact to state and local preparedness, especially when foreign-owned property is located near military installations, energy facilities, transportation corridors, communications infrastructure, or other sensitive assets. The discussion will also consider the challenges these acquisitions present for state and local governments, including information sharing, threat assessment, land-use planning, and coordination with federal partners to identify and mitigate emerging security risks.
